SUBJECT: Implementation Guidance for Sections 1050 (b) and 1050 (c) of the Water Resources Reform and Development Act of 2014 (WRRDA 2014) – Namings

1. Section 1050 (b) of the Water Resources Reform and Development Act of 2014, Public Law 113-121, redesignated the name of the "Lower Mississippi River Museum and Riverfront Interpretive Site" to the "Jesse Brent Lower Mississippi River Museum and Riverfront Interpretive Site". Section 103(c)(1) of the Water Resources Development Act of 1992 (106 Stat. 4811) has been amended by striking "Lower Mississippi River Museum and Riverfront Interpretive Site" and inserting "Jesse Brent Lower Mississippi River Museum and Riverfront Interpretive Site". (copy enclosed).
2. Any reference in a law, map, regulation, document, paper, or other record of the United States to the "Lower Mississippi River Museum and Riverfront Interpretive Site" shall be deemed to be a reference to the "Jesse Brent Lower Mississippi River Museum and Riverfront Interpretive Site". As appropriate and practicable, any physical references to Lower Mississippi River Museum and Riverfront Interpretive Site shall be changed to "Jesse Brent Lower Mississippi River Museum and Riverfront Interpretive Site", along with all project references in USACE databases and budgetary information.
3. Section 1050 (c) of the Water Resources Reform and Development Act of 2014, Public Law 113-121, redesignated the name of the the lock and dam located in Modoc, Illinois, authorized by the Act of July 3, 1930 (46 Stat. 927), and commonly known as the Kaskaskia Lock and Dam, as the "Jerry F. Costello Lock and Dam".
4. Any reference in a law, map, regulation, document, paper, or other record of the United States to the lock and dam located in Modoc, Illinois, commonly known as the Kaskaskia Lock and Dam shall be deemed to be a reference to the "Jerry F. Costello Lock and Dam". As appropriate and practicable, any physical references to the project commonly known as the Kaskaskia Lock and Dam shall be changed to "Jerry F. Costello Lock and Dam", along with all project references in USACE databases and budgetary information".

SEC. 1050. NAMINGS.

(b) Redesignation of Lower Mississippi River Museum and Riverfront Interpretive Site.—

(1) IN GENERAL.—Section 103(c)(1) of the Water Resources Development Act of 1992 (106 Stat. 4811) is amended by striking “Lower Mississippi River Museum and Riverfront Interpretive Site” and inserting “Jesse Brent Lower Mississippi River Museum and Riverfront Interpretive Site”.

(2) REFERENCES.—Any reference in a law, map, regulation, document, paper, or other record of the United States to the museum and interpretive site referred to in paragraph (1) shall be deemed to be a reference to the “Jesse Brent Lower Mississippi River Museum and Riverfront Interpretive Site”.

(c) Jerry F. Costello Lock and Dam.—

(1) REDESIGNATION.—The lock and dam located in Modoc, Illinois, authorized by the Act of July 3, 1930 (46 Stat. 927), and commonly known as the Kaskaskia Lock and Dam, is redesignated as the “Jerry F. Costello Lock and Dam”.

(2) REFERENCES.—Any reference in a law, map, regulation, document, paper, or other record of the United States to the lock and dam referred to in section 1 shall be deemed to be a reference to the “Jerry F. Costello Lock and Dam”.
